#### WHAT HAPPENS NEXT?

- You and the housing specialist develop a personal plan for modifying your home.
- We send a list of requests to qualified contractors based on your personal plan.
- The contractors send us bids for this work.
- A contractor is then selected.
- We contact the property owner and get signed permission because the work we do is permanent.
- We arrange a time with you to begin the work.
